A late penalty payment of \$1,250 may be made at entry on Thursday, July 26, 2018. After payment of 1% to all owners of horses finishing sixth through last, 55% of the remaining purse shall be paid to the winner, 20% to second, 15% to third, 7.5% to fourth, and 2.5% to fifth. Weight, 122 lbs. Field size will be limited to 12 starters. Preference in the draw for post positions will be based on money earned. Starters to be named through the entry box by the closing time of entries. **FINAL NOMINATIONS CLOSED AT 3:00PM SATURDAY, JULY 14, 2018 WITH 18.**

SIPPIN FIRE broke sharply then was unhurried early, advanced four-wide through the second turn, engaged WEEKEND WIZARD with a furlong to run, vied with that foe through hard drive and edged away through the final yards. WEEKEND WIZARD was away in good order to duel for the early advantage with FREIBURG while racing three-wide, opened a clear lead nearing the quarter, responded challenged by the winner in mid-stretch, vied with that foe and grudgingly gave way late. ELLIOTT BAY settled off the leaders early, raced three-wide through the second turn and finished willingly in the drive to gain the show. ARGOSY FLEET chased the pace of WEEKEND WIZARD while racing three-wide, moved inside through the second turn and failed to gain in the drive. SCHOENHARDT lacked early speed, raced between foes through the back-stretch, moved five-wide through the second turn and finished evenly in the drive. CHECK AND RAISE was void of early speed, saved ground through the second turn, angled out approaching the stretch and failed to menace. SMOOTHEE LEE was forwardly placed early, raced four-wide through the second turn and weakened. TAKE CHARGE DEPUTY showed no early speed, raced four-wide through the first turn, five-wide through the second turn and was not a factor. FREIBURG disputed the pace from the inside for three-quarters, weakened and was eased.
